The Summit was held virtually for one day and the Showcase was held at the Adelaide Pavilion in collaboration with SA Health.



PEPA AND IPEPA SA PROJECT

Empowering Health Professionals to deliver palliative care

PEPA and IPEPA National is led by Queensland University of Technology (QUT), with PCSA as the organisation delivering South Australian Activities.

The Program of Experience in the Palliative Approach (PEPA) aims to enhance the capacity of health professionals to deliver a palliative care approach through their participation in either clinical placements in specialist palliative care services or interactive workshops.

The Indigenous Program of Experience in the Palliative Approach (IPEPA) is a grassroots approach to breaking down the barriers to palliative care for Aboriginal and Torres Strait Islander peoples across Australia.

PCSA was delighted to close off our 3 year contract with QUT to deliver PEPA SA and continue for a further three years.



This project is led by Australian General Practice Accreditation Limited (AGPAL), with PCSA as a partnership organisation.

Education and training materials provided by the Gwandalan Project support relationships between service providers, frontline staff and Aboriginal and Torres Strait Islander Communities through cross-cultural education and the sharing of knowledge. This increases capacity in those who care for Aboriginal and Torres Strait Islander peoples during their palliative and end-of-life journey.

The project successfully provided E-Learning Modules, Dillybag (resources) and a Yarning Place in 2022-23, throughout Australia.
